#### 134th Command Post Vacancies - Two Traditional Command Post Controller Positions Open

Mission of the Command Post Controller is to provide the wing commander the capability to execute command and control of his forces in response to any call of the military command structure. The controller is the eyes, ears, and mouthpiece of the Commander.

The Controller:

\* Transmits instructions to aircrews and support assets to coordinate launch, recall, execute, and terminate missions in support of nuclear operational events.

\* In a minimum time and without error, must be able to copy, decode, validate, process, and relay the Emergency Action Message (EAM) to appropriate personnel and complete checklist actions in response to any tasking received from Higher Headquarters.



\* Maintains OPLAN 8010 certification in the Emergency Action Procedures of the Joint Chiefs of Staff (CJCS), United States Strategic Command (USSTRATCOM), Air Mobility Command (AMC), and the Air National Guard Bureau (ANG).

\* Maintains 24/7 classified communication systems used for receiving and transmitting message traffic.

\* Establish priority of actions based on a variety of situations, and uses controller judgment to resolve multiple tasking received simultaneously.

\* Controls movement and status of the Alert Force and coordinates Alert Force requirements with key agencies.

\* Briefs the Crisis Action Team (CAT) and the Alert Force on a variety of critical situations.

\* Must learn and retain for instant recall and reference, a considerable body of knowledge related to Emergency Action Procedures (EAP). Monthly testing includes (2) 25 question test, a OPLAN 8010 50 question test, and multiple scenario training.

\* Responds to numerous quick reaction situations initiating Emergency Actions Procedures and Quick Reaction Checklist.

\* Executes and supports all aspects of the Tanker Strategic Aircraft Reconstitution Team (TSART), including establishing classified satellite communication systems.

\* Utilizes a variety of COMSEC documents , including Top Secret.

\* Good communication and written skills are a requirement to accomplish duties and responsibilities.

\* Top Secret Security Clearance and a rotating 24/7 work schedule.

\* Air Force in-residence courses Command Post Apprentice (Keesler AFB,MS), Joint Nuclear Command and Control (Offutt AFB, NE), AMC Command and Control Course (Scott AFB, IL).

9/25/2009 - McGHEE TYSON ANGB, Tenn. -- A servicemember from the 228th Combat Communications Squadron here received the Air Force Commendation Medal from Col. Richard B. Howard, commander of The I.G. Brown Air National Guard Training and Education Center, during his commander's call at Wilson Hall here, Sept. 25.

Staff Sgt. Jessica C. Parks, a knowledge operations specialist who has been performing active duty operational support days at the Training and Education Center, distinguished herself by outstanding achievement as a curriculum developer from Nov. 24, 2008 to Aug. 1, 2009 while assigned to the Transformative Education (TE) branch.

"I was excited to receive this award," said Parks, whose tour at the Training and Education Center will end on Sept. 30. "I loved working with the TE branch on their projects and it was nice to be recognized for the things I did here." Parks has been working on a special project for the Air Force's Barnes Center for Enlisted Education, which is located at Maxwell-Gunter Air Force Base, Ala.

"We had a huge strategic level project," said Chief Master Sgt. Christopher J. Coyne, Chief of the TE branch, of their project to redesign the paper-based Noncommissioned Officer Academy Course 0009 into a web-based medium for

#### enhanced learning.

Parks' expertise allowed for the seamless conversion of 21 in-residence lesson plans to a distance learning format using audio, video and graphic material to create an interactive experience for Air National Guard noncommissioned officers. Her demonstrated leadership in organizing, scheduling and coordinating support for the project eliminated costly work stoppage and project delays and enabled the TE branch to meet the project's time-sensitive deadline. "There is no way the project would have ever been completed on time without her," said Coyne. "It was her skills, attitude and energy that helped us to deliver it." But this wasn't only a win for the TE branch. Parks has learned new skills that she has already put to good use at her unit.

"I've learned a lot of things over this period," said Parks. "It's helped me to put a lesson plan together for my job and I was able to teach AFRIMS (Air Force Records Information Management Systems) and ERM (Electronic Records Management) to others at my unit and it's actually helped everyone out. "The Course 0009 project is currently in the evaluation phase at the Air Force's Barnes Center for Enlisted Education. The I.G. Brown Air National Guard Training and Education Center's Transformative Education branch is the Air National Guard's design center for Advanced Distributive Learning initiatives and provides training in numerous personal and professional development courses.

#### THE SERVICEMEMBERS CIVIL RELIEF ACT

The Servicemembers Civil Relief Act (SCRA), signed into law in 2003, provides many legal protections for members of the Armed Forces. Members of the National Guard recalled for State duty are protected by the SCRA when called to state active duty under Title 32, if the duty is because of a federal emergency, the request for active duty is made by the President or Secretary of Defense, and the member is activated for longer than 30 days.

As noted, the SCRA provides many protections, but this article will discuss some of the most common:

Termination of Residential Leases. The SCRA allows individuals to break a lease when they go onto active duty, if the lease was entered into before going onto active duty. Additionally, the act allows a servicemember to terminate a residential lease entered into while in the military, if the member receives permanent change of station (PCS) orders, or orders to deploy for a period of not less than 90 days. To break a lease under these provisions, the servicemember must make the request in writing, and must include a copy of their orders (orders placing them on active duty, PCS orders, or deployment orders). The termination date for a lease that requires monthly rent, the earliest termination date is 30 days after the first date on which the next payment is due, following proper notification of termination of lease.

Automobile Leases. Military members may also terminate automobile leases in certain circumstances. Just like with residential leases, if a member enters into an automobile lease before going on active duty, the member may request termination of the lease when he/she goes onto active duty. However, for this to apply, the active duty must be for at least 180 continuous days. To terminate an automobile lease, the member must make the request in writing, along with a copy of orders. The member must then return the vehicle to the lessor within 15 days of delivery of the termination notice. The lessor is prohibited from charging an early lease termination fee. However, any taxes, summonses, and title and registration fees and any other obligation and liability of the lessee in accordance with the terms of the lease, including reasonable charges to the lessee for excess wear, use and mileage, that are due and unpaid at the time of termination of the lease shall be paid by the lessee.

Evictions from leased housing. A service member may seek protection from eviction under SCRA. The rented/leased property must be occupied by the service member or his/her dependents for the purpose of housing, and the rent cannot exceed \$2,400. The servicemember or dependent who has received notice of an eviction must submit a request to the court for protection under the SCRA. If the court finds that the service member's military duties have materially affected his ability to pay his rent timely, the judge may order a stay, postponement, of the eviction proceeding for up to 3 months or make any other "just" order.

Installment Contracts. The SCRA gives certain protections against repossessions for installment contracts (including automobile leases). If the contract was entered into before going on active duty and at least one payment was made before that time, the creditor cannot repossess the property, while the member is on active duty, nor can they terminate the contract for breach, without a court order.

<u>6% Interest Rate.</u> If a service member's military obligation has affected his/her ability to pay on financial obligations such as credit cards, loans, mortgages, etc., the service member can have his/her interest rate capped at 6% for the duration of the service member's military obligation. In order for an obligation or liability of a servicemember to be subject to the interest rate limitation, the servicemember must provide to the creditor written notice and a copy of the military orders calling the servicemember to military service. The portion of the loan above 6 percent is permanently forgiven. Furthermore, the monthly payment must be reduced by the amount of interest saved during the covered period.

<u>Court Proceedings</u>. If a servicemember is a defendant in a civil court proceeding, the court <u>may</u>, on its own motion, grant a 90-day stay (delay) in the proceedings. If the servicemember asks for a stay, the court <u>must</u> grant a minimum 90 day stay, if: The servicemember submits a letter or other communication setting forth facts stating the manner in which current military duty requirements materially affect the servicemember's ability to appear and stating a date when the servicemember will be available to appear; and the servicemember subletter or other communication from the servicemember's commanding officer stating that the servicemember's current military duty prevents appearance and that military leave is not authorized for the servicemember at the time of the letter. The provision applies to civil lawsuits, suits for paternity, child custody suits, and bankruptcy debtor/creditor meetings, and administrative proceedings.

The new act specifically states that a servicemember communicating with the court requesting a stay does not constitute an appearance for jurisdictional purposes and does not constitute a waiver of any substantive or procedural defense (including a defense relating to lack of personal jurisdiction).

A servicemember who is granted a stay may request an additional stay, if he/she can show that military requirements affect his/her ability to appear (commander's letter is also needed). However, the court is not obligated to grant the additional stay. If the court refuses to grant an additional stay of proceedings, the court must appoint counsel to represent the servicemember in the action or proceeding.

If a default judgment is entered in a civil action against a servicemember during the servicemember's period of military service (or within 60 days after termination of or release from such military service), the court entering the judgment must, upon application by or on behalf of the servicemember, reopen the judgment for the purpose of allowing the servicemember to defend the action if it appears that-- the servicemember was materially affected by reason of that military service in making a defense to the action; and the servicemember has a meritorious or legal defense to the action or some part of it.

These are just a few of the common provisions that service members should be aware of. The Base Legal Office is available to answer questions and/or draft any documents allowing service members to take advantage of the protections of the SCRA. #### **DID YOU KNOW?**

On Armed Forces Day, November 12, 1956 ten streets on McGhee Tyson Air Force Base were renamed for area airmen who were victims of World War II, and the Korean War era. Colonel George Simlar was the Base Commander at the time.

One of the streets named was Briscoe Drive. It was named after Lt Russell Briscoe Jr, who was the first Knox County casualty of the Korean War. Lt Briscoe was a Knoxville High School graduate in 1943 and entered the Air Force shortly after. Lt Briscoe was in training for a possible invasion of Japan, when the atomic bomb suddenly brought WW II to a close. He was discharged to the inactive reserves in November 1945. After separation he attended a little school we still know as the University of Tennessee. He reentered the Air Force and was assigned to DOW Air Force, Bangor Maine, then was transferred overseas to Johnson Air Base near Tokyo, Japan, flying the F-80 Shooting Star Jet Fighter.

After a hurried check-out in the P-51 Mustang Fighter, he moved to Pohang-dong, Korea. On 6 Aug 1950, barely six weeks after the armed conflict began, Lt. Briscoe leading a flight of two P-51's on a low level armed reconnaissance mission in the Yongduk area, was hit by hostile ground fire and crashed. He had previously been awarded the Air Medal with two Oak Leaf Clusters for distinguishing himself in battle from 8 July to 2 Aug 1950. On 3 August he led a flight of Mustangs that had destroyed three locomotives, four rail cars, a fuel dump, and many Communist group troops, for this air action he was awarded the Distinguished Flying Cross. The next time you drive down Briscoe Drive, think about what you did to receive your medals!



### **INFORMATION SECURITY**

#### ALERT:

A website has been identified claiming to be the official website of the Air Force Portal (legitimate address: https://www.my.af.mil/faf/FAF/fafHome. jsp). Although the website, www.AirForcePortal.net, contains a plethora of information, it is not the official AF site. It uses common phishing practices to gain access to logins, passwords and credentials.

#### **Portable Electronic Devices (PED)**

Portable Electronic Devices (PEDs), according to AFI 33-100, is a generic title used to describe a myriad of small electronic items (e.g. Personal Digital Assistants (PDAs), Cellular Telephones (CTs), two-way pagers, audio/video recording devices, and hand-held/laptop computers) widely available. Almost all have wireless telecommunications capabilities that offer tremendous advantages for government users. However, there are key things that PED users need to know and understand.

- Connecting non-government-owned PEDs to an Air Force network is prohibited. If individuals have a requirement to use a PED on an Air Force network, they must request issuance of a governmentowned PED.
- > Once issued, users must comply with Air Force IS operating instructions.
- Encrypt data transmitted through a commercial or wireless network (data-in-transit).
- Protect data stored or processed by the PED against tampering, theft, and loss.
- Encrypt all stored information (data-at-rest) not otherwise approved for public release. Contact your CSA for approved procedures for encrypting. Contact your Freedom of Information Act Officer or Public Affairs Officer for information on determining what information is releasable to the public.
- Obtain DAA approval before using a PED for storing or processing High Impact Personally Identifiable Information (PII) and restrict use to protected workplaces. PEDs taken outside protected workplaces must adhere to the following additional security requirements:
- > The PED must be signed in and out of protected workplaces with a supervising official.
- Do not use wireless-enabled PEDs for storing, processing or transmitting classified information without explicit written approval of the DAA and cognizant security authority.
- Do not connect PEDs to more than one network at a time. PEDs connected directly to a Department of Defense (DoD)-wired network (e.g., via a hot synch connection to a workstation) must not be permitted to operate wirelessly.
- Do not use wireless-enabled PEDs in areas where classified information is discussed or processed without coordination from the installation EMSEC manager.
- > Do not enable wireless capability unless necessary for the mission and approved by the DAA.
- Immediately report lost or stolen PEDs to the Client Support Administrator (CSA) or Information Security Officer (ISO).

## Do You Know the Symptoms of H1N1?

#### What are the symptoms of H1N1... and how are they different from the common cold?

Symptom	Cold	H1N1 Flu
Fever	Fever is rare with a cold.	Fever is usually present with the flu in up to 80% of all flu cases. A temperature of 100°F or higher for 3 to 4 days is associated with the flu.
Coughing	A hacking, productive (mucus- producing) cough is often present with a cold.	A non-productive (non-mucus producing) cough is usually present with the flu (sometimes referred to as dry cough).
Aches	Slight body aches and pains can be part of a cold.	Severe aches and pains are common with the flu.
Stuffy Nose	Stuffy nose is commonly present with a cold and typically resolves spontaneously within a week.	Stuffy nose is not commonly present with the flu.
Chills	Chills are uncommon with a cold.	60% of people who have the flu experience chills.
Tiredness	Tiredness is fairly mild with a cold.	Tiredness is moderate to severe with the flu.
Sneezing	Sneezing is commonly present with a cold.	Sneezing is not common with the flu.
Sudden Symptoms	Cold symptoms tend to develop over a few days.	The flu has a rapid onset within 3-6 hours. The flu hits hard and includes sudden symptoms like high fever, aches and pains.
Headache	A headache is fairly uncommon with a cold.	A headache is very common with the flu, present in 80% of flu cases.
Sore Throat	Sore throat is commonly present with a cold.	Sore throat is not commonly present with the flu.
Chest Discomfort	Chest discomfort is mild to moderate with a cold.	Chest discomfort is often severe with the flu.

If you think you have the H1N1 flu, you should take a few common-sense steps to protect your friends, family members, and coworkers. For instance, if you feel sick, stay home until you feel better and have gone at least 24 hours without relying on medicine to break your fever.

In addition, wash your hands, linens, dishes, and so on thoroughly. And cover your mouth and nose with a tissue when you cough or sneeze--and then throw the tissue away immediately. Finally, if you have to share a small space with other people, consider wearing a facemask to help make sure you don't spread the flu to the people around you.

### LINE OF DUTY DETERMINATIONS FOR INJURIES/ILLNESS WHILE IN A DUTY STATUS

If you are injured or contract an illness while in a duty status (IDT, UTA, PT, TPPA, AD Orders less than 31 days) it is imperative that you notify your immediate supervisor and the 134th Medical Group regardless of the extent of your illness or injury for completion of a Line of Duty (LOD) Determination. Payment of medical claims for LOD injuries or illnesses are covered by TRICARE through coordination with the 134th Medical Group and the Military Medical Support Office (MMSO).

It is in your best interest to ensure that a Line of Duty determination is completed and annotated in your medical record in case there are any residual effects from the illness or injury at a later date that



require continued care or possible claims through the Veterans Administration for disability.
