"SANTA COP 2009" A RECORD YEAR

"Santa's here!" The words heard over and over as members of the Santa Cops procession delivered presents

to patients, their siblings, and the staff at East Tennessee Children's Hospital on December 5, 2009.

The brainchild of Senior Master Sgt. Steven Payne and Master Sgt. Richard Parker, the Santa Cops program began as a project for the 134th Security Forces Squadron in 1999. Now, ten years later, the 134th SFS still spearheads the program with incredible support from throughout the McGhee Tyson ANGB community. The recipient of voluntary donations from on and off base, the Santa Cops program brought in over \$18,000.00 in 2009.

According to Master Sgt.
Parker, the night before the visit to the hospital, shoppers purchased gifts for the forty-six children the ETCH staff had estimated would be present on delivery day. More than fifty people showed up to show how much they care and help make the requested purchases and to get a few extra things they thought the kids would like. ETCH staff give an estimate of how many gifts

will be needed, but the exact number is never known until delivery day – and it's usually a lot more. This year, gifts were given to over one hundred twenty-five children.

In past years, in excess of one hundred participants from all over McGhee Tyson have descended on the hospital on

delivery day to help spread cheer. This year, due to the H1N1 Flue pandemic, hospital staff had to limit the Santa

Cops procession to just fifteen people. Santa, his elves, and a few close friends were all that were able to go from room-to-room.

Although less people were able to participate in delivering the presents, the amount of joy experienced by those receiving the gifts was not diminished. Shouts of "Oh boy!", "Look!" and "Just what I asked Santa for!" were heard as packages were unwrapped and hoped for gifts were revealed. A few patients and their families were so overwhelmed they were speechless. Many parents could do nothing more than just cry at the joy and love extended to their child, but Jenny S., whose daughter was undergoing surgery at ETCH, summed up the thoughts of many of those present. "To see great and brought lots of joy."

A lot of conversations were heard around the base the day after the gifts were delivered as people told of their experiences delivering

gifts and telling how they plan to be involved next year. A great example of how the members of the 134th ARW are active in the community, Santa Cops will continue in 2010.

134th Airman is Satellite NCOA Distinguished Graduate

12/15/2009 - McGHEE TYSON AIR NATIONAL GUARD BASE, Tenn. -- A member of the 134th Air Refueling Wing received the distinguished graduate award for her accomplishments at the Satellite Noncommissioned Officer (NCO) Academy during the class graduation ceremony at The I.G. Brown Air National Guard Training and Education Center here, Dec. 15.

Tech. Sgt. Venus D. Julien, a knowledge operations craftsman with the 134th communications squadron, was one of the top graduates of 130 NCOs who attended Class 10-2.

The Distinguished Graduate Award is presented to students in the top ten percent of the class. It is based on objective and performance evaluations, demonstrated leadership, and performance as a team player. The NCO Academy is a requirement for promotion to master sergeant. Air National Guardsmen have the option of taking the correspondence course or attending either the traditional 6-week in-residence school or the satellite program. The Satellite NCO Academy is a 12-week distance learning program that was specifically designed for Airmen who cannot attend the six-week program for whatever reason, but still want the education, experience and credit of attending the program in-residence. During the first phase of the course,

students attend four-hour training sessions two nights a week at their home station. Trained facilitators at their unit help them participate in interactive training lessons which are broadcast over the Air National Guard's Warrior Network satellite system. In the second phase, students travel here to McGhee Tyson for a two-week capstone in-residence experience at the Training and Education Center.

Tennessee Guard Maintains, Operates Northern Iraq Aviation Asset

CONTINGENCY OPERATING BASE SPEICHER, Iraq (11/30/09) - Nestled in a remote location, by design, is a special aviation operation in northwest Iraq.

Soldiers of the Tennessee Army National Guard's 1-230th Air Cavalry Squadron maintain and operate a Forward Arming and Refueling Point (FARP), 24 hours-aday, seven days-a-week.

2nd Lt. Jason Shaffer, the platoon leader and FARP officer-in-charge of Troop G, 1-230th ACS, said Soldiers who work on the FARP are responsible for refueling and rearming various types of helicopters at multiple "points" or helipads.

Shaffer has served in the Tennessee Army Guard for two years, after six years of active-duty service. He's responsible for the overall functioning of three FARPs. He ensures that the correct quality, grade, type and amount of fuel is delivered to each FARP, in addition to spot checking the completion of daily service and maintenance tasks.

Shaffer explained why he has a special confidence in his Soldiers handpicked to work on the FARP.

"The Soldiers that we've chosen to work out here must be exceptionally disciplined," said Shaffer. "Quite unlike operations at the more established FOB FARPs, the

operations ... run akin to those of a civilian fire station.

"When radios come on out here, wherever the Soldiers are - and I do mean 'wherever' -- they immediately drop anything they're doing, put on their protective equipment, run to the fuel trucks and [service the aircraft]. At other locations, Soldiers are on shift. Here Soldiers work when the aircraft are flying which is all the time, any time."

Staff Sgt. Derrall Tilson, who is Shaffer's fuel and ammunition platoon section sergeant with 1-230th ACS, has deployed multiple times with the Tennessee Guard and also as an active-duty infantryman.

He's been in and around FARPs since he transferred to the Guard in 1991. "My biggest concern with operations on a FARP is always safety," said Tilson. "In this job, we're talking about aircraft that have active weapons platforms with rotors turning and Soldiers pumping fuel into helicopters, often at night. Our guys out here are special."

It was at Fort Sill, Okla., when the unit learned that only about 20 percent of the Soldiers were already school-qualified to do the aviation job, Shaffer explained.

"We had cooks and water guys and [personnel with] various other job skills. We had to get everyone trained and properly qualified. And that has been my greatest joy; teaching and training Soldiers who know very little about this job to where they are all proficient." he added.

The squadron's executive officer said the squadron operates three FARPs throughout Task Force Marne's area of operation.

"The Soldiers are truly remarkable," explained Maj. Beason Layne, Executive Officer, 1-230th ACS. "They have all performed exceedingly well, and have now pumped close to 1.7 million gallons of fuel without incident."

One of those young Soldiers is Spc. David Romano, a food service specialist who was cross-trained into FARP operations.

For the young Jackson, Tenn., native, switching from the kitchen to the FARP wasn't a hard choice. "I like to cook, but I'm from Tennessee; I really like being outside," said Romano. "Getting a chance to meet local Iraqis every once in a while and being out here in nature, getting to look at the hills every day, that's the reason being deployed is okay for me."

The 1-230th ACS deployed with more than 600 soldiers from units in Smyrna, Alcoa and Jackson, Tenn., back in July, 2009. The Squadron is task organized with a Headquarters, Headquarters Troop. Troops A, B and C are equipped with the unit's OH-58D Kiowa Warrior helicopters whose primary missions are reconnaissance and security operations. Troop D is equipped with Black Hawk helicopters used to transport troops and supplies.


Troops E and F handle the battalion's maintenance, component and specialty repair work, respectively. Finally, Troop G provides ground transportation, downed aircraft recovery capability and fuel and ammunition supply in addition to other forward support functions.

DININGOUTRULES OF THE MESS

Thou shalt not murder the Queen's English

Thou shalt not open the hangar doors (talk shop)

Thou shalt always use the proper toasting procedure

Thou shalt be painfully regarded if thy clip-on bow tie rides at an obvious list Thou shalt be forgiven, however, if thee also ride at a comparable list

Thou shalt consume thy meal in a manner becoming gentlepersons

Thou shalt not laugh at ridiculously funny comments unless the President first shows approval by laughing

Thou shalt express thy approval by tapping thy spoon on the table.

Clapping of thy hands will not be tolerated.

When the mess adjourns, thou shalt rise and wait for the President and guests to leave

Thou shalt fall into disrepute with thy peers of the pleats of thy cummerbund are inverted

GROGBOWLRULES

When the President directs a violator to the grog bowl, the individual proceeds to the bowl promptly. Upon arriving at the grog bowl, the violator does the following:

- 1. Does an about face and salutes the President. (President is not required to return the salute.)
- 2. Turns to the bowl and fills the cup.
- 3. Does another about face and toasts the mess, "To the Mess".
- 4. Drains the contents of the cup without removing it from the lips.
- 5. Inverts the cup over head to prove it is empty.
- 6. Does another about face. Replaces the cup, again salutes the President, returns to their seat. With the exception of the toast, "To the Mess," the violator is not permitted to speak during this process.

Finance News

TRAVEL PAY

1. There has been some confusion lately on a few reimbursement items. The finance office doesn't want anyone to be denied a reimbursement or have any out of pocket expenses due to a lack of training, so here are a few notes to keep in mind when you travel.

First are rental car reimbursements. It is a requirement to book all rental car and airline information through the Commercial Ticket Office (CTO) which in our case is SATO. The JFTR Chap 3 Part B U3120 states that it is a DOD mandatory policy to use an available CTO to arrange official travel, including transportation and rental cars. Also, if you decide to upgrade from a standard rate vehicle then you will have to pay the difference out of your pocket. Furthermore, if you want to go sightseeing while at your TDY location, the fuel used should not be claimed as a reimbursable expense.

Second is Baggage fees. Military members are generally exempt from paying for baggage. Most airlines authorize military member one free baggage claim, but keep in mind there are still weight limits. Most of the kiosks do not have an option for military, so checked bags at the kiosk will be charged. The easiest way to avoid these charges and save your organization's funds is to check in with an agent. Also, if you have "EXCESS" baggage then it has to state in your orders that you're authorized reimbursement for excess baggage. Excess means your baggage is overweight or more than one bag. 2. The General Services Administration (GSA) has just released new mileage reimbursement rates for privately owned automobiles (POA), motorcycles and airplanes when used for official travel. The following new mileage rates go into effect on January 1, 2010:

- POA: \$0.50/mile

Motorcycles: \$0.47/mileAirplanes: \$1.29/milePCS: \$0.165/mile

3. The new per diem rates for 2010 went into effect 1 October 2009. Standard lodging rate continues to be \$70/night, standard meal rate changed from \$36 to \$41, but the most significant change is that the incidentals expenses rate for CONUS changed from \$3 to \$5. 4. Defense Travel System (DTS)

A change for 2010 is that all technician status travel orders and vouchers will be processed through the Defense Travel System (DTS). The finance office will be providing DTS training for all technicians. The dates for this training and implementation will be announced at a later time.



Effective 4 December, the Base Education and Training Office will be accepting applications for the Tennessee National Guard Tuition Assistance Scholarship Program. Applications being accepted are for the Spring 2010 Semester only. Applications for classes starting before or after the Spring 2010 Semester will not be accepted. The Base Education and Training Office must receive all applications along with application addendum, current passing Fitness Assessment and degree plan no later than close of business on 7 February 2010.

A Tennessee National Guard member who meets the requirements of the program may receive a tuition assistance scholarship based upon available funds. To be eligible for the tuition assistance scholarship a guard member must be a member of the Tennessee National Guard on or before the first day of class for the semester, trimester, quarter or term and have successfully completed basic military training on or before the first day of class for the semester, trimester, quarter or term. The guard member must be a satisfactory participant in the Tennessee National Guard, live within the borders of the state of Tennessee and have a current passing Fitness Assessment score of 75 or higher. An unsatisfactory participant is a member who has accumulated 9 or more unexcused absences from Unit Training Assemblies (UTA) within a 12 month period, or who, without proper authority, fails to attend or complete the entire period of annual training. The guard member must serve in the Tennessee National Guard beyond the end of the term for which the tuition assistance scholarship is granted. The guard member must also successfully complete all courses for which benefits are received.

Members of the Tennessee National Guard who meet the requirements of the tuition assistance program may apply using the Tennessee National Guard Tuition Assistance Scholarship Application Form. The form can be obtained from the Base Education and Training Office and requires the member's commander or designated unit representative's endorsement. Once the application has been completed and signed by the member and commander or unit representative, the application will be returned to the Base Education and Training Office. The Base Education and Training Office will then review the application for completeness and then forward to State Headquarters for processing. *Those interested in applying for the tuition assistance program must apply for each semester or term for which they intend to utilize the scholarship.*

The tuition assistance scholarship must be applied to an educational institution, not to the individual. An educational institution is defined as any state supported university, community college or vocational or technical school or any private college or university located within the State of Tennessee. In no case will the combination of this tuition assistance scholarship with any other tuition assistance program exceed 100% of the student's tuition cost.

After submitting an application, if you decide to make any changes to classes that you listed on your application for tuition assistance to include withdraw of any or all classes listed please contact the Base Education and Training Office as soon as possible. This is important in order to keep from dispensing funds and then having to recoup them at a later date. Failure to successfully complete a course for which tuition assistance was received will cause the guard member to make restitution to the State of Tennessee.

TENNESSEE NATIONAL GUARD TUITION ASSISTANCE APPLICATION ADDENDUM

A Tennessee National Guard member who meets the requirements of the program may receive a tuition assistance scholarship based upon available funds. The Guard member must serve in the Tennessee National Guard beyond the end of the term for which the tuition assistance scholarship is granted. The Guard member must also successfully complete all courses for which benefits are received(Applicant's Initials)
Members of the Tennessee National Guard who meet the requirements of the Tuition Assistance Program may apply using the Tennessee National Guard Tuition Assistance Scholarship Application Form. The form can be obtained from the Base Education and Training Office (BETO) and requires the member's Commander or his /her designated unit representative's endorsement. Once the application has been completed and signed by the member and Commander or his / her designated unit representative, the application will be returned to the BETO. It is highly recommended that the application be hand carried by the applicant to the BETO. The BETO will then review the application for completeness and then forward it to State Headquarters for processing. Those interested in applying for the Tuition Assistance Program must apply for each Semester or term for which they intend to utilize the scholarship. (Applicant's Initials)
The tuition assistance scholarship must be applied to an educational institution, not to the individual. An educational institution is defined as any state supported university, community college or vocational or technical school or any private college or university located within the State of Tennessee. In no case will the combination of this tuition assistance scholarship with any other tuition assistance program exceed 100% of the student's tuition cost(Applicant's Initials)
After submitting an application, if you decide to make any changes to classes that you listed on your application for Tuition Assistance to include withdraw of any or all classes listed please contact the BETO as soon as possible. This is important in order to keep from dispensing funds and then having to recoup them at a later date. An official transcript reflecting all courses listed on your Tuition Assistance Application for which you have applied must be submitted to the BETO immediately upon completion of that Semester. Failure to provide the required documents will prevent you from applying for future Semesters and may result in Judicia Punishment. Failure to successfully complete a course or withdraw from a course for which tuition assistance was received will cause the Guard member to make restitution to the State of Tennessee(Applicant's Initials)
I understand that I must attach a copy of my "Degree Plan" to my application each time that I submit an application for Tuitior Assistance(Applicant's Initials)
My current legal residence is within the borders of the state of Tennessee(Applicant's Initials)
I understand that that in order to be eligible for the Tennessee National Guard Tuition Assistance Scholarship Program I must have a current passing <u>Fitness Assessment score of 75 or higher</u> . I also understand that I will be required to provide a copy of the assessmen with the scholarship application each time I apply for tuition assistance(Applicant's Initials)
Funding will be provided to the maximum amounts possible to each applicant until funds are exhausted on an annual basis. Therefore the amount of assistance provided may vary from Semester to Semester based upon the funds appropriated and the number of applications received. Payment of the Tuition Assistance will be made directly to your educational institution when the money is released by the State. DO NOT rely on State Tuition Assistance to pay your full Tuition or be paid at the start of the Semester for which you are applying. Payment of the Tuition Assistance is made by the State of Tennessee at the earliest possible date; however is could be delayed until the middle or the end of the Semester for which you are applying. Therefore be prepared to cover your financial obligations with the educational institution you are attending(Applicant's Initials)

This event collects old computers, laptops, parts, peripherals, and a few other electronic items. *All of these items have hazardous materials and should not be disposed of with your regular garbage*. This event provides the community with the opportunity to properly recycle these items.

Acceptable Items

Computer equipment such as: PC systems, CPUs, monitors, mice, keyboards, printers, scanners, laptops, modems, hard drives, speakers, power cords, cables, phones, powers strips, desktop copiers, fax machines, <u>small</u> TVs (no consoles), peripherals, cell phones, etc.

Unacceptable Items

Microwaves, electronics containing hazardous chemicals such as lab equipment, small refrigerators (contain freon), small stoves, small appliances, cardboard, scrap metal, aluminum cans, or newspapers.

Involved Charities

There are no fees being charged to drop off equipment, but monetary donations will gladly be accepted and will benefit Goodwill Industries and the Optimist Club of West Knoxville.

Why Recycle?

Computer monitors and televisions are hazardous because they contain significant amounts of lead. Printed circuit boards contain hazardous metals such as lead, chromium, cadmium and mercury, with significant variation depending on the board. Mercury-containing components like switches and relays are found in some electronic and electrical products. PCBs may be found in televisions and computers made before the early 1980s. The OEA encourages residents to take advantage of local recycling opportunities. Recycling old electronic equipment keeps hazardous materials out of waste and makes it possible to recover resources. Recyclers typically disassemble units, salvage reusable parts, and send materials to final processors.

Volunteering

The Base Environmental Department is looking for volunteers to participate in this electronics recycling event. Volunteers will be asked to participate for a period of 4 hours with multiple opportunities throughout the day to choose from.
