# **Maintainers Keep Tankers in Tip-Top Shape**

There are many interesting processes that take place in the 134th Maintenance World such as aircraft washes. Phase inspections, etc. One of the more interesting ones to watch is putting an aircraft up on jacks or more

commonly known as "jacking" an airplane. MSgt Bill Harness, Shop Chief of the Repair & Reclamation (R & R) shop, took me through this process.

The first step happens before the airplane comes into the hangar. The Crew Chiefs configure the fuel load on the airplane to obtain the correct center of (CG) which gravity the makes aircraft is then towed by Tech. Sgt. Kendra M Owenby) into the hangar and

the jacking team takes over. The jacking team consists of eight people. Let's take a look at each of their duties.

The first team member is the jacking team supervisor. He/she is responsible for the entire operation including safety. The second team member is the jacking manifold operator. They are responsible for operating the jacking manifold which controls the pressure going to each jack. They are in constant communication with the third team member which is the Plum bob operator. The Plum bob operator is watching a mechanism which tells them if the aircraft is level as it is rising. He/she

gives hand signals to the jacking manifold operator that tells them if the aircraft is level or needs adjusting and from which direction. The jacking manifold operator will adjust the pressure to the appropriate jack by turning

a control valve until the aircraft is level. The other five team members monitor the five jacks as the aircraft is rising. Their primary responsibility is to ensure the jacks stay seated on all three jack pads which keeps the airplane They also stable. monitor the collar on the jack ram. On the way up they keep the collar lowered and on the way down the keep it raised. This is in case the jack fails it will fall on the collar

instead of releasing from the aircraft. Once the aircraft is jacked to the appropriate level, another jack is placed under the nose for stabilization.

This is just one of the many processes that the R & R shop is responsible for. MSgt Harness has 2 fulltime and fourteen Traditional Guardsmen that are also responsible for maintaining the flight controls, aircraft windows, tires, and landing gear. These are just a few of the responsibilities that the R & R shop meticulously handles. They do an outstanding job and they are a vital part of the 134th Maintenance Group.

# What do the "Miracle on the Hudson" and Aug. 6, 2009 have in common?

As we all know the "Miracle on the Hudson" was a result of geese meeting US Airways Flight 1549. The outcome of this untimely meeting was a calculated execution of emergency landing procedures;

inoperative engines finally crashing into the Hudson River. All 155 personnel aboard survived with very minor injuries. Pilot Chelsey "Sully" Sullenberger is given the credit for saving many lives. The rest is history. Yet what does this event have to do with the events of Aug. 6, 2009?

What may not be known, is that on Aug. 6, 2009, a similar event occurred at McGhee Tyson with one of our own KC-135Rs. The mission was to transport Security Forces personnel to an exercise. Events up to

takeoff were normal, and just like US Airways Flight 1549 a flock of birds flight path coincided with the path of a KC-135R. Birds and tanker met at the moment the KC-135 was lifting for takeoff position. The pigeons impacted the right side of the aircraft including the number three engine. Most engines similar to, and including the KC-135R, are tested against a four-pound frozen bird, but not against 12 pigeons, much less goose-sized birds. The crew evaluated the situation. Fortunately, this bird strike did not have such dramatic results as the US Airways flight. Our own KC-135 crew masterfully returned the aircraft to a safe landing at McGhee Tyson where the aircraft underwent numerous inspections and repairs.

Besides this pigeon strike at McGhee Tyson, the 134 ARW experienced a dramatic increase (300% over the past several years) in bird strikes. Last year saw a dramatic increase in bird strikes, and this year the 134th is on track to beat last year's record numbers.

Fortunately no more serious incidents occurred during the year, yet the damage potential to the aircraft, crews and local area still exists. In order to determine the hazards and how to reduce them, the

134<sup>th</sup> has recieved some outside assistance.

The National Guard Bureau (NGB) and United States Department of Agriculture (USDA) have an agreement where NGB will supply funds to local USDA/ APHIS (Animal Plant Health Inspection Services) agents to perform a variety of wildlife assessments and mitigation functions on Guard bases. The 134th ARW was given a grant for APHIS personnel to perform these functions for

one year. APHIS personnel have already begun their assessments in and around the airport property.

Over the next year, these assessments will expand into control/mitigation measures against wildlife that threaten the safe execution of aircraft operations. The individual performing these functions is Mr. Brian Kirby, a USDA Wildlife Management Specialist who is trained in wildlife hazard management techniques.

Additionally, Mr. Kirby is authorized a variety of control measures such as traps, firearms, and toxicants. Your safety office, the USDA personnel and a variety of other agencies both on and off base are working together to ensure everyone's safety and an understanding of APHIS personnel working areas. Attached is the 'office' AHPIS personnel utilize.

Mr. Kirby will be one and around base at a variety of times. Please allow him to perform his duties so that we all are less likely to experience our own "Miracle on the Hudson".



# 13.2.3 Calling a Room to Attention

The enlisted custom is for the first person to see an officer entering the room to call the room to attention. If an officer of equal or higher rank is already in the room, the room is not called to attention. When the officer departs, the room is called to attention again. However, it is not proper for officers to follow this practice. How do you then get junior officers to render proper courtesies when a senior officer enters the room? Here's how many units over the years have handled the situation. When gathered in a conference room or theater awaiting the arrival of a senior officer, someone is posted to watch for his or her arrival. As the senior officer approaches, the watcher may sound off "at ease, ladies and gentlemen," as a warning. When the senior enters the room, one officer will announce "Ladies and gentlemen, the commanding officer," or "Ladies and gentlemen, General Jones." All officers stand at attention until told to be seated. Note that common sense has to play in deciding when a work center is called to attention. When a senior officer enters an operations center, for example, it's customary for them to be announced, but operators remain seated at their consoles and politely acknowledge the superior's presence by sitting at attention and making eye contact, if doing so does not affect the performance of their job.

# Combating Human Trafficking (CTIP)

In January of this year 10 American missionaries went to Haiti to render assistance to some of the displaced children. When they take some of the children out of the country without proper authorization they were arrested and charged with human trafficking. So just what is human trafficking and how might it impact me as a member of the military? Following is a brief description of the DoD directive regarding Combating Human Trafficking:


- ➤ National Security Presidential Directiive 22 (2002) mandates a "zero tolerance" policy among members of the US armed services and civilian employees/contractors.
- > Trafficking is recruitment, transportation, transfer, harboring or receipt of persons by means of threat, force, coercion, abduction, fraud, deception, abuse or exploitation.
- > Defenseless women and children are often victimized due to: poverty, low family status, ill informed families sell children, cultures of shame ban trafficked persons.
- Perpetrators include international organized crime, small trafficking groups that specialize in one specific country and individual freelancers.
- **YOU** assist perpetrators by: hiring prostitutes, attending strip clubs, patronizing businesses that use formed labor, not reporting cases of suspected trafficking.
- ➤ If you believe you have witnessed a trafficking operation or believe a person who is being trafficked, you must report the information to your chain of command or IG.
- Military and statutory punishments for trafficking in persons or supporting those who do include imprisonment and fines.
- ➤ A wing commander guidance memorandum is posted on your unit bulletin board.
- ➤ Your CTIP manager is Lt Col Sandra Grice, 134 ARW/IG, 865-985-4444.



# Why Wait in Line???

Starting 1 August, McGhee Tyson ANGB will convert to Electronic Records. For the next six months, the 134th Personnel Flight will audit all records and send them to a designated contractor to be scanned and placed in the "Virtual" system.

The Air Force's goal is to facilitate a paperless organization. All future paperwork will be sent to the Air Force Personnel Center where it will be scanned and will be viewable to the member online 24/7. In fact, many applications are available online now that allow you to look at your personnel record, awards and decorations, review point summaries, RIPs, statement of service, DD214's, performance report information and many other personnel functions. These applications are available through the VPC-GR (https://arpc.afrc.af.mil/vPC-GR) and the Virtual MPF (https://www.afpc.randolph.af.mil/vs).

All the information is readily available and no action is needed by the member. Your Military Personnel Flight is working hard to upload your information and afford you the convenience of having your personnel information anytime/ anyplace 24/7. So with all this information at your finger tips, why wait in line at your Military Personnel Flight.

# INFORMATION SECURITY

### **Telecommunications & Monitoring**

ANG members use various forms of unsecured telecommunications systems such as telephones, cell phones, radios, facsimile, pagers, computer networks, and other wired or wireless electronic devices to conduct day-to-day official business. Never discuss sensitive or classified information over an unsecured device.

Of course the Air Force monitors all unsecured and unprotected telecommunications systems to determine if they are being used to transmit sensitive or classified information. General notification of monitoring is provided to all users of DoD telecommunications systems and devices through the use of various methods such as visual aids like the DD Form 2056 affixed to each unsecured phone. Your phone is missing this red label? Please contact your unit Telephone Control Officer to ensure the phone is properly marked. This label is one of the methods used to ensure that you are aware and consent to telecommunications monitoring by using the device. Below are some rules of practice that you may not be aware of:


### **Rules of Practice**

<u>FAX Cover Sheets</u> - DODM 4525.8-M, AF Sup 1, Official Mail Manual, mandates the use of AF Form 3535, as a cover sheet for fax transmission as it already contains the notice and consent statement. However, if any other cover sheet is used, the following notice and consent statement must be printed on it: "Do not transmit classified information over unsecured telecommunications systems. Official DOD telecommunications systems are subject to monitoring. Using DOD telecommunications systems constitutes consent to monitoring."

<u>Portable Electronic Devices</u> - When issued a government device, personnel are required to sign a form that includes the notice and consent statement. These forms remain on file for 6 months after the device is turned in.

Hand Held Radios - Either the DD Form 2056 must be affixed or a consent form must be signed.

# Physical Security Guidance

- Monitor and control who is entering your workplace: current employees, former employees, and commercial delivery and service personnel.
- Check identification and ask individuals to identify the purpose of their visit to your workplace.
- Report broken doors, windows, and locks to your organization's or building's security personnel as soon as possible.
- Make back-ups or copies of sensitive and critical information and databases.
- Store, lock, and inventory your organization's keys, access cards, uniforms, badges, and vehicles.
- Monitor and report suspicious activity in or near your facility's entry/exit points, loading docks, parking areas, garages, and immediate vicinity.
- Report suspicious-looking packages to your local police. DO NOT OPEN or TOUCH.
- Shred or destroy all documents that contain sensitive personal or organizational information that is no longer needed.
- Keep an inventory of your most critical equipment, hardware, and software.
- Store and lock your personal items such as wallets, purses, and identification when not in use.





Call your local police department to report a suspicious person, vehicle, or activity in or near your workplace.
