## Airman Becomes United States Citizen

"I'm proud to be an American. I can say that now" said Senior Airman Regina Trivette following her Naturalization Oath. It has been a long journey

for Trivette to arrive at this point. The journey started in 1987 in Iloilo City Philippines where she was born and raised.

In 1987 Trivette's mother left the Philippines and came to New Jersey as a nurse, later moving to New York where her family would join her. Trivette proudly explains her mother's motivation for traveling to America "She came here to better our lives, the money in America is good. A nurse now in the Philippines would probably make \$200 a month if that. She came here on a working visa. The hospitals have agencies in the Philippines and

elsewhere who hire nurses to come to work for them on a contract for however many years."

Trivette explains "My mom petitioned for me and my family to come here so we could all be together." On Nov. 19, 1991 the 14 year old Trivette and the rest of her family joined her mother in New York. "When we got here in November of 91 she was in the process of getting her permanent residency, which she got in February 92. Then we applied for ours while we were here. Me, my dad, and brother all got ours in July 92. She got her citizenship in 96. My brother and I are in the same boat, waiting on the oath taking."

Trivette listed some of the obstacles in her way until she obtains her America citizenship. "I didn't realize you couldn't reenlist if you didn't have your citizenship... I can't be an officer if I don't have citizenship. I can't vote. I can not travel with a US passport. Tommy (her husband) and I travel a lot and we have to go through different lines at the airport. He goes through one for US passports and I go through one for non US passports."

Ultimately her decision to join the military was not based on a mere easing of impediments but rather the sense of camaraderie she felt at McGhee Tyson Air Guard Base. "I wanted to be a part of this family. When I came here to visit there was something specific about this base that felt like a family. I wanted to be a part of the circle."

So, Trivette set out to labor through the process of earning her American Citizenship. The process for an immigrant to obtain citizenship is lengthy and detailed. You go online (Trivette cont. on pg 3)

and print out a ten page application which you submit to Nebraska. They send you a letter to say it is in the process. You then receive a second letter that tells you where to go to get your fingerprints. A third letter arrives to inform you of your interview date. You are given a study sheet with 96 questions on it for the interview. The questions are based on history, civics, and your ability to read, write and listen in English. "My interview was in Memphis Tennessee on February 3. Bear in mind I sent in my application back in May of last year." The second part of the interview can be waived under different circumstances. They ask you six of the questions. The last letter announces where you will take the naturalization oath. There are three locations in East Tennessee for the oath taking; Greenville, Knoxville, and Chattanooga.

Trivette exudes a humbleness at working so hard to achieve a dream of hers. "You know when you're a kid and you have big dreams? I never dreamed of coming here, much less being in the military. I can't believe it. I can't believe I am where I am right now. I am just thankful to God that I am where I am right now."

On Wednesday March 11 Trivette obtained her goal of becoming an American citizen three years after joining the Tennessee Air Guard. The important ceremony took place at Niswonger Performing Arts Center in Greeneville. Trivette anxiously awaited the ceremony. Present to support her were: her husband Master Sgt. Thomas Trivette, Maj. Jason Brock, and the Public Affairs staff.

A plethora of people slowly filed into the auditorium to check in for the ceremony. As they checked in

they took their assigned seats in the middle of the auditorium. Families and friends flanked the applicants. The mood in the room was a mixture of serious, anxious and expectant. A representative of the court announced that there were 248 applicants present, who represented 67 different nationalities. Among the 248 people waiting to be

citizens were Trivette, her brother, and his wife. Of those present 40 requested name changes as part of their naturalization and ten requested a modification of the oath due to religious beliefs. All the applicants read the Oath of Allegiance in unison with judge Honorable Marcia P. Parsons.

After the oath was complete the judge said a few words about what it meant. "I celebrate with you and them (the families) your newly granted citizenship. Witnessing your naturalization should renew pride in our nation...Your presence here today gives me confidence that America continues to be a land of opportunity. Your presence here today ensures me that you will help ensure America's practices follow her ideals... I am both honored and humbled, I congratulate you."

Parsons then gave the new citizens to stand and testify what American Citizenship meant to them. Many of the proud Americans took the opportunity to express their joy and shared sentiment on the occasion. The two most poignant statements were: "All of us today have two birthdays to celebrate" and "Now at last I can say I am proud to be an American."

# Maintenance Minute

When you are 50 years old, (not that I would know, but you can ask some of my co-workers) your body seems to need more and more attention. The same goes with 50-year-old airplanes. As time goes by, screws get stripped, brackets get broken, rivets pop, etc. In addition to these minor discrepancies, airplanes need repainting, corrosion treatment and other modifications to maintain structural integrity and performance. All these repairs and more fall under the Aircraft Structural Maintenance Shop better known as the Sheet Metal Shop. The 134th Sheet Metal Shop operates under the direction of MSgt Sean Nicholson. MSgt Nicholson leads a crew of 12 that includes 6 full-time personnel and 6 traditional guardsmen that are responsible for assessing damage, advising on structural repairs, and numerous other procedures that keep our airplanes together.

Since most Sheet Metal work takes time and precision, the majority of their work occurs when an airplane comes in for a Periodic Inspection (Phase). In fact, 90% of their time is spent in Phase completing tasks

such as manufacturing plastic, fiberglass, bonded honeycomb, composite structural components, tubing, and cable assemblies. The Sheet Metal Shop usually ends up with over 125 discrepancies each time an aircraft comes into Phase. Removing and treating corrosion, applying protective coatings, and painting aircraft markings are just a few of the

jobs awaiting Sheet Metal during Phase Inspections. They also use metal working equipment and tools to form, cut, and/or bend damaged parts to meet required



specifications.

Recently, McGhee Tyson swapped aircraft with another unit and the Sheet Metal Shop discovered some severe corrosion while doing their Acceptance Inspection. Discovering the corrosion was vital to the aircraft's stability and structural integrity. Due to the severity of the corrosion, repairs for this discovery will take almost a month to complete. With another Phase Inspection just around the corner, the pressure is on to accomplish this task. If the past is any indication, Sheet Metal will pass this test with flying colors.

# April is Sexual Assault Awareness Month

April is National Sexual Assault Awareness Month. Your Air National Guard leadership has been aggressively addressing this national problem. They are dedicated to preventing sexual assault, and if it occurs, responding appropriately to sexual assault within the Air National Guard.

Regrettably, sexual assault is happening within the Air National Guard to our men and women. Sexual assault is a crime. It degrades our readiness and disrupts unit cohesion. Our Core Values are built on themes of respect and mutual dependence. But with sexual assault, everybody loses--the victim, the perpetrator, the squadron, and the wing. It is up to all Airmen to help prevent this heinous crime.

Air National Guardsmen who are victims of sexual assault can experience serious, long-term trauma, including depression, anxiety disorders, PTSD, suicidal thoughts and substance abuse. When one of our Air National Guardsmen is harmed, it affects everyone.

We have made significant strides in our prevention and response efforts over the past year with mandatory awareness training to over 360,000 Airmen, worldwide. Sexual Assault Response Coordinators and Victim Advocates are trained and are actively working to educate personnel to prevent this crime, while providing dedicated and caring assistance to victims.

Depending on your military status, members who have been sexually assaulted may confidentially receive medical treatment and support without automatically triggering a criminal investigation. Similarly, victims who would like for the case to be investigated can make an immediate unrestricted report, and still receive the support of the sexual assault prevention and response team.

Remember, integrity involves responsibility, accountability and self-respect. Airmen with integrity are dependable and consistent. They behave in a manner that brings credit to themselves, their unit, the Air National Guard and the Air Force.

Airmen who value their teammates and our military more than their self-interests display fundamental respect for others as well as discipline and self control. Airmen who are committed to excellence apply that standard to their personal lives, community involvement and operational initiatives.

Let us continue our rise to that higher plane where every Airman is treated with respect and protected from harm. Our mission and our Core Values demand nothing less.

## Victim Advocates, a helping hand in times of need

Victim advocates are available for you if you are a victim of sexual assault.

Victim advocates are military personnel and DoD civilian employees selected by the base's sexual assault response coordinator to provide essential support, liaison services and care to a sexual assault victim.

Victim advocates are volunteers who must possess the maturity and experience to assist in very sensitive situations.

Responsibilities of a victim advocate include:

- Providing crisis intervention, referral and ongoing non-clinical support.
- Providing information on available options and resources to assist the victim in making informed decisions.
- Continuing services until the victim states support is no longer needed.
- Accompanying the victim, at their request, during investigative interviews and medical examinations.

Victim advocates do not provide counseling or other professional services to a victim.

Victims of sexual assault often feel ashamed and confused. The advocate is there to help the victim through the process. Often times, the Victim advocate is there to simply to listen.

Victim advocates are the backbone of the Sexual Assault Prevention and Response Program. They are volunteers and they do not take the job lightly. They put their personal needs aside to help victims, listen without prejudice and are dedicated to the members of the 134th Air Refueling Wing.

# 1st Sergeant Position Available

There is a vacancy for the position of First Sergeant (Master Sgt.) in the Support Group. We are currently accepting applications for retraining and assignment to this duty. If you are interested in applying, and if you meet the minimum listed qualifications, please follow the instructions in the "How To Apply" section below.



## **Minimum Qualifications**

-Must be currently serving in the grade of Master Sgt., Tech. Sgt may be selected if they are immediately promotable, and they must be promoted on or before the date of assignment to the UMD position of First Sergeant.

**Selected candidates must sign the following statement:** "I agree to attend the USAF First Sergeant Academy within 12 months of my assignment as First Sergeant. Failure to complete this requirement will result in my removal from the First Sergeant position and immediate demotion (if promoted as a result of assignment to this position)."

- Must be highly motivated and capable of fulfilling the role of the First Sergeant as prescribed in AFI 36-2113, Chapter 1. Must have exceptional leadership and managerial skills.
- Must have ability to speak distinctly.
- Must have a minimum physical profile PULHES 322221
- Must be financially stable.
- Must meet minimum weight and body fat standards and overall image must exceed minimum standards.
- Must have completed the NCO Academy either in residence or by correspondence prior to application.
- Must agree to serve no less than 3 years as a First Sergeant after completion of the First Sergeant Academy.
- Must pass Air Force Physical Fitness test.

## **How to Apply:**

Prepare the following documents:

- AF Form 1206, Nomination for Award. (Use this form to document your individual qualifications)
- Letter of Recommendation from your current unit Commander
- Current RIP

**Submit your application to** the 134MSF/DPM (Chief Master Sgt. Linda Gibson) **no later than May 29.** Qualified applicants will be scheduled to personally appear before a selection board. Candidates must wear the service dress uniform to meet the selection board.

If you have questions concerning the duties of a First Sergeant, please refer to AFI 36-2113. Questions relating to the selection board should be addressed to Chief Master Sgt. Jimmy Long, the Wing Command Chief Master Sergeant.

### Student Flight – Listen Up!

- **Roll Call – Sunday at 1215** you will report to the Headquarters building. Saturday, and Sunday morning you will report to your unit for roll call. You must report to roll call in order to get paid.
- **Pre-BMT class – Sunday** of each drill at **1220**. This is a **mandatory** class (as directed by Col. Dearing) until you ship out to BMT. Any absence must be cleared through the recruiting office supervisor, Master Sgt. Bart Welch, ahead of time.
- **In Processing Checklist - Saturday at 0900** of your first drill weekend you are required to report to the photo lab (in the headquarters building) to have your **portrait** taken. This is **mandatory** in order to complete your in processing checklist.
- **Security Clearance Process** – All new enlistees please ensure you have logged onto [www.opm.gov/e-gip](http://www.opm.gov/e-gip), to initiate your clearance. Once you have logged on, you have **60 DAYS** to complete this. This is a **mandatory** item. **Failure to complete on time will result in a counseling session with the Mission Support Flight Commander, Lt. Col. Steve Keeney.** Note: answer ‘unknown’ the first time and only the first time you answer the question ‘place of birth.’

# APRIL HRA MINUTE






